Background details: This has reference to respective e-mails from M/s Transrail and M/s Sterlite dated 06.08.2022 and 17.08.2022 regarding manufacturer approval of M/s Usha Martin for supply of Galvanized Core Wire of Ultra High Strength and Mega Strength. Based on the request and submission of relevant documents, assesment was carried out by our representative at above mentioned works on 09.09.2022 and 10.09.2022. Please note that further approval shall be considered based upon performance, quality and supplies made during this approval period. It is to be ensured that request for renewal of above approval shall be forwarded at least one month before expiry of this approval.

Please note that the items supplied shall meet the requirements of POWERGRID Specifications/ Approved Drawing/ Data Sheets/ GTP/MQP, relevant IS standards. Manufacturer shall ensure that the above documents are available at the works so that proper inspection is carried out without delay. If, at any point of time, any abnormality is noticed in this regard, we reserve the right to increase our involvement by way of additional inspection and/or additional customer inspection points (CIP) at any stage or withdraw this approval with immediate effect.

Special Remarks:
Following points are also to be ensured by M/s Usha Martin:

- As committed by M/s Usha Martin, suitable tensile testing machine with extensometer with provision for testing samples for "Elongation at break" shall be installed by them by January'2023. Till then samples for "Elongation at break" shall be tested at third party laboratory or Conductor manufacturer's testing facilities.
- As an improvement point and agreed by M/s Usha Martin, sensor based digital display shall be installed near Galvanizing area for temperature monitoring of Zinc bath by November'2022.
- Suitable action to be taken regarding inclusion of Galvanizing process in the upcoming revision of pollution clearance certificate pertaining to M/s Usha Martin.
