We further report that as at 31st March 2023, the reported total issued, paid up and listed share capital of the Company stands inflated by 230 equity shares. This was caused due to an erroneous additional electronic transfer of 230 equity shares to Investor Education & Protection Fund (IEPF) under the Ministry of Corporate Affairs (MCA) by way of corporate action executed on 29th September, 2020 by Central Depository Services Ltd. (CDSL) and Register & Transfer Agent (RTA) of the Company. This has been appropriately reported by the Company as per Regulation 76(3) of the SEBI (Depository & Participants) Regulations, 2018. The Company, CDSL and Registrar are continuously following up with IEPF authorities for necessary rectification in records. The reported total issued, paid up and listed equity share capital of the Company stood inflated by 230 equity shares as on 31.03.2021 and 31.03.2022.

Assumptions & Limitation of scope and review:

- 1. Compliance of the applicable laws and ensuring the authenticity of documents and information furnished, are the responsibilities of the management of the listed entity.
- 2. Our responsibility is to report based upon our examination of relevant documents and information. This is neither an audit nor an expression of opinion.
- 3. We have not verified the correctness and appropriateness of financial Records and Books of Accounts of the listed entity.
