Details of the violation(s)/contravention(s) committed or alleged to be committed	The Company dispatched consignment from its plant in the State of Punjab under proper tax invoice which was being carried by transporter's vehicle to the buyer in the State of Tamil Nadu. The transporter's vehicle was intercepted by the State Tax Officer, Chennai (STO, Chennai) alleging that the consignment was being unloaded at a place other than the designated delivery address of the buyer and accordingly the demand was raised on the buyer by STO Chennai. Since as per the terms of contract with buyer, the consignment supplied by the Company was on F.O.R basis, the responsibility to deliver the consignment to the buyer was with the Company. The penalty amount of Rs 11,64,464/- was paid under protest by the Company on 4th October, 2023 under relevant provisions of the Tamil Nadu GST Act and CGST Act to enable release of the consignment. Thereafter STO, Chennai passed the release order on 5th October, 2023 for release of the consignment.
